

**PARLIAMENT OF NAURU**  
**DRAFT HANSARD**  
**Seventeenth Parliament**  
**First Sitting of the First Meeting**  
**Tuesday, 28<sup>th</sup> August 2007**

**Mr Speaker, Hon. Ludwig Scotty, M.P., took the Chair at 10.00 a.m. and read Prayers.**

The Chairman of the House, Mr. Frederick Cain, took the Chair and read Prayers.

**Mr. Chairman:** Good morning Members and welcome to this inaugural sitting of the Seventeenth Parliament.

Let me first of all congratulate you all on your recent election as Members of this august House and I trust that most of you have recovered from your week-end celebrations and ready to tackle the tasks ahead of you.

We will now commence our business in accordance with our programme and I shall commence first with the Proclamation of the Speaker which reads as follows, and I quote -

*'Whereas the Sixteenth Parliament of the Republic of Nauru was dissolved at the end of the 26<sup>th</sup> day of July 2007;*

*And Whereas by a Writ issued by the Speaker by and with the advice of the President and dated the 20<sup>th</sup> day of July 2007, the Speaker appointed the twenty-fifth day of August 2007 for the holding of a General Election of Members of Parliament in accordance with the advice of the President;*

*And Whereas I have received the Return of the said Writ notifying me that the said General Election was duly held and of the names of the persons elected thereat;*

*I, Valdon Dowiyogo, in accordance with the advice of the President do appoint and proclaim that the Seventeenth Parliament of Nauru shall meet at Parliament House at the hour of ten o'clock on the morning of Tuesday, 28<sup>th</sup> August 2007 and shall proceed to transact the following business, namely -*

*First, the election of a Member of Parliament to be Speaker of Parliament;*

*Secondly, the election of a Member of Parliament to be Deputy Speaker of Parliament;*

*And in that order before the transaction of any other business;*

*Parliament must at its first sitting thereafter elect a Member of Parliament to be President of the Republic. God save the Republic!*

*(Signed) Valdon Dowiyogo, M.P., Speaker of Parliament*

*Given and made this twenty fourth day of August, Two thousand and seven.'*

Under Standing Order 3(b) the Chief Justice or a person authorised by him for the purpose, shall thereupon enter the Chamber for the purpose of swearing in Members. Unfortunately, the Chief Justice is unable to be with us on this occasion and has authorised the Resident Magistrate, Mr. Eperama Rokoiko to administer the Oath to Members.

Honourable Members, I now lay on the Table of the House the Return of the Writ which reads as under, and I quote -

*"The Honourable Speaker, Republic of Nauru,*

*The Honourable Speaker, this is to advise you in declaration that in obedience to your Writ of 27<sup>th</sup> day of July 2007, I have caused a parliamentary election on the date appointed by your, to wit, twenty fifty day of August 2007.*

*I hereby return the said Writ attaching herewith the declaration of the result of election in the Constituency elected to be the Members of the Seventeenth Parliamentary Election on the Republic.*

*Given under my hand at Nauru this 27<sup>th</sup> day of the month of August, 2007.*

The results of the election is as under –

For the Constituency of Aiwo – Dantes Tsitsi and Rene Reynaldo Harris;

For the Constituency of Anabar/Ijuw/Anibare – Ludwig Scotty and Riddel Akua;

For the Constituency of Boe – Baron Divavesi Waqa and Mathew Batsiua,

For the Constituency of Buada – Shadlog Bernicke and Roland Kun,

For the Constituency of Ewa/Anetan – Cyril Buraman and Marcus Stephen,

For the Constituency of Meneng – Sprent Jared Dabwido and Rykers Solomon,

For the Constituency of Ubenide – David Adeang, Frederick Pitcher, Valdón Dowiyogo and Fabian Ribauw, and

For the Constituency of Yaren – Dominic Joselito Tabuna and Kieren Keke.

Our next order of business is for the swearing in of Members, and I will ask the Resident Magistrate to enter the Chamber for this purpose.

### **Resident Magistrate enters Chamber for the swearing in of the Members of the Seventeenth Parliament.**

#### **Members take the Oath alphabetically, constituency-wise.**

#### **(Resident Magistrates leaves the Chamber)**

**Mr. Chairman:** Honourable Members, the next business before us is the election of the Speaker, and according to Article 34, Parliament shall, before it proceeds to the despatch of any other business, elect one of its Members to be Speaker. Therefore, are there any nominations for the position of Speaker?

**Mr. Adeang (Ubenide):** Mr. Speaker, I have the privilege to move that the Hon. Valdón Dowiyogo, Member for Ubenide, do take the Chair of the House as Speaker.

**Mr. Chairman:** Any seconder to the motion?

**Mr. Pitcher (Ubenide):** I second the nomination.

**Mr. Chairman:** Duly seconded by the Mr. Pitcher, Member for Ubenide. Does Mr. Dowiyogo accept his nomination?

**Mr. Dowiyogo (Ubenide):** Yes, Mr. Chairman, thank you very much, I do accept. Thank you.

**Mr. Chairman:** Are there any further nominations, from the floor, for the position of Speaker?

**Mr. Stephen (Ewa/Anetan):** Thank you Mr. Chairman, anga ateng nominate eiy amea engab ino pago bwe enim eiy Speaker me ranga bitune ewak, the Hon. Rene Harris.

**Mr. Chairman:** Thank you, the Hon. Member has nominated the Hon. Member for Aiwo, Hon. Rene Harris. Is there any seconder to that nomination?

**Mr. Ribauw (Ubenide):** Anga second eiy bita motion.

**Mr. Chairman:** The motion has been seconded by the Member for Ubenide, Mr. Ribauw. Does Mr. Harris accept the nomination?

**Mr. Harris (Aiwo):** Mr. Chairman, gain kerita bitune imin eame me animen kor amen bwio bwain Aiwo nan egirow ame iya anim etubuda ina, me ita ngana anan accept bwe amerumena dango tengeiyo.

**Mr. Chairman:** The Member has accepted his nomination. Is there any further nomination for the position of the speakership?

There being none, we have two Members nominated, the Member for Ubenide, Hon. Valdón Dowiyogo and the Member for Aiwo, Hon. René Harris. As normal this will be conducted by secret ballot and I will ask Counsel to distribute the ballot papers.

**Election of Speaker done by secret ballot.**

**Mr. Chairman:** The results of the voting is as follows – Mr. Dowiyogo 13 votes, Mr. Harris – 5 votes; so I declare the Member for Ubenide, Mr. Dowiyogo, Speaker of the Seventeenth Parliament. I will ask the mover and seconder to escort the Speaker to his Chair. Thank you.

**(Hon. Speaker, Valdón Dowiyogo, is then escorted to the Speaker's Chair by his proposer and seconder.)**

**The Speaker, Hon. Valdón Dowiyogo, M.P., presiding.**

**Mr. Speaker:** Thank you Members, we will continue with our business.  
I now call for nominations for the Deputy Speaker of this House.

**Mr. Solomon (Meneng):** Mr. Speaker, I wish to move that the Member for Meneng, Hon. Sprent Dabwido, do take the Chair of the House as Deputy Speaker.

**Mr. D. Adeang (Ubenide);** Mr. Speaker, I second the nomination.

**Mr. Tabuna (Yaren):** Mr. Speaker, I second the nomination.

**Mr. Speaker:** Hon. Sprent Dabwido of Meneng, do you accept the nomination?

**Mr. Dabwido (Meneng):** Mr. Speaker, otubwa amerumena amen nominate eiyo, yes I accept the nomination. Tubwa.

**Mr. Speaker:** Thank you Member for Meneng. Are there any other nominations?

**Mr. Ribauw (Ubenide):** Mr. Speaker, tubwa. Ateng nominate eiy amea wanga colleague from Ewa and Anetan, Hon. Marcus Stephen, bwe enim eiy Deputy Speaker.

**Mr. Harris (Aiwo):** Anga second eiy bita.

**Mr. Speaker:** Mr. Marcus Stephen, do you accept the nomination?

**Mr. Stephen:** Mr. Speaker, tsinia engame ied bwe eimwi bwe anim babiyi bita etang of Deputy Speaker then anan epon burio bwe anim accept.

**Mr. Speaker:** The Member for Ewa and Anetan has accepted the nomination.

Members, any other nominations? Garo ngana magen iyu nominations, therefore we will do the same procedure dogin ngaga there are two nominations. Inan opwe ea gamie wamie ballot papers. Amea Counsel nan pass around eiy mungana wamie ballot papers.

**Election of Deputy Speaker conducted by secret ballot.**

**Mr. Speaker:** Honourable Members, ngana results dogin elect eiyin amea Deputy Speaker – Hon. Sprent Dabwido – 9 votes, Hon. Marcus Stephen – 8 votes, therefore I declare Hon. Sprent Dabwido as the Deputy Speaker of the Seventeenth Parliament.

For your further information ngea amea Deputy Speaker he is also the Chairman of Committees.

Next under Standing Order 6, I will call for nominations for two Members to be Deputy Chairmen of Committees.

**Mr. Stephen (Ewa/Anetan):** Sorry, Mr. Speaker, me ateng seek eiy wam clarification. Tsinia wo nominate eiy two Members and they become Deputy Chairmen of Committees can they also be nominated for President?

**Mr. Speaker:** Sorry Hon. Stephen me eo kor mo aeo kaiot bita.

**Mr. Stephen (Ewa/Anetan):** Mr. Speaker, tobeiy ngana garon eken, tsinia elect eiyin two Members

**Mr. Speaker:** Hon. Stephen, obereiy eken.

I have been advised by the Clerk ngana ngarumena engame nominate eiy dogin Chairmen of Committees, neither of them can be nominated for the seat of the presidency.

**Mr. Stephen (Ewa/Anetan):** Mr. Speaker, thank you, ngea ngea wanga question, if they get elected not if they are nominated. They can be nominated, but if they are not elected then they can. Eimwi?

**Mr. Speaker:** Hon. Marcus Stephen, thank you me yes that is the answer, they cannot be nominated as President once they are elected as Deputy Chairmen of Committees. Thank you.

Now I will call for nominations for two Members to be Deputy Chairmen of Committees.

**Mr. Adeang (Ubenide):** Mr. Speaker, I nominate the Member for Aiwo, the Hon. Dantes Tsitsi.

**Mr. Waqa (Boe):** Secunder.

**Mr. Speaker:** Hon. Dantes Tsitsi, do you accept the nomination.

**Mr. Tsitsi (Aiwo):** Thank you Mr. Speaker, me otubwa bed amerumena amen nominate eiy me anan accept eiy bita position. Thank you.

**Mr. Speaker:** Thank you Member for Aiwo. Any other nominations?

**Mr. Ribauw (Ubenide):** Mr. Speaker, tubwa kor. Ateng bed nominate eiy amea wanga colleague amen Aiwo bed ion, iya enim eiy gona bed ranga murana Chair. Tubwa.

**Mr. Stephen (Ewa/Anetan):** I second that, Mr. Speaker.

**Mr. Speaker:** Hon. Rene Harris, do you accept the nomination?

**Mr. Harris (Aiwo):** Tsinia arumen amen Aiwo na, inan ekeowen won voice dobwain Aiwo ina yong, no thank you.

**Mr. Speaker:** Hon. Rene Harris of Aiwo has declined the nomination. Any other nominations?

**Mr. Kun (Buada):** Mr. Speaker, ateng nominate eiy amea wanga colleague, Member for Boe, Mathew Batsiua.

**Mr. Waqa (Boe):-** Secunder.

**Mr. Speaker:** Hon. Mathew Batsiua, do you accept the nomination?

**Mr. Batsiua (Boe):** Accept.

**Mr. Speaker:** Thank you Member for Boe.

**Mr. Harris (Aiwo):** Mr. Speaker, nominate eiy amea new Member for Buada bwe enim eiy acting whatever it is; eken ngea? Deputy Chairman, bwe ur nim kereri epo amune wanga colleague amen Aiwo, me anan kong a amea Mathew Batsiua bwe enim withdraw eiy egon.

**Mr. Speaker:** The nomination has been seconded by the Hon. Marcus Stephen. Hon. Shadlog Bernicke, do you accept the nomination?

**Mr. Bernicke (Buada):** Otubwa kor amea dango, me I happily decline. Tubwa kor.

**Mr. Speaker:** The Member for Buada has declined the nomination. I call for further nominations.

Members you are reminded ngana ngea Deputy Chairmen, oaro deo aiquen. There are no more nominations so I therefore declare Hon. Dantes Tsitsi, Member for Aiwo and Hon. Mathew Batsiua Member for Boe to be the two Members to be Deputy Chairmen of Committees. Thank you Members.

Members, in accordance with Article 16 of the Constitution, I now call for nominations for the President of the Republic of Nauru. Are there any nominations?

**Mr. Stephen (Ewa/Anetan):** Mr. Speaker, ang gona break eken dogin an tsimine woun bitune iyien President?

**Mr. Adeang (Ubenide):** Mr. Speaker, inan tsimine engame object ea bita bwe ogiten og duwoma ngama.

**Mr. Speaker:** Member for Ewa and Anetan, what is the purpose of bita break ngago wo kongon?

**Mr. Stephen (Ewa/Anetan):** Ouge anga tsimine woun iya ang nim onano eken bwe ang nim aea, ang nim konani President.

**Mr. Adeang (Ubenide):** Ouge anga ngea ngea dogin ang nim homework ngago ian obwen ata metu. Tubwa, Mr. Speaker.

**Mr. Speaker:** Members you were given more than 24 hours, more like 48 hours bwe mwa nim lobby me iyiy wamie President. You had been given ample time.

**Mr. Stephen (Ewa/Anetan):** Mr. Speaker, eo fair ia ouga. Ngama ekeow wama audo mimin, bakoro wama audo.

**Mr. Adeang (Ubenide):** Point of order, Mr. Speaker.

**Mr. Speaker:** A point of order has been raised by the Member for Ubenide.

**Mr. Ribauw (Ubenide):** Wo ougea gama 48 hours, we had been given ample time, egadame wanga notice about 2 o'clock yesterday afternoon ngana ma epo ngabumine ean 10 o'clock, so if I count that it is less than 24, it is almost 20 or even less than 20. Me anga anan kongaw bed, implore you bwe wo nim oiya gama a short break tsinia wo gona, me especially mibuna engame eko towon. Anga eo goeow od ange ngea, me wam staff happily obuida on.

**Mr. Speaker:** Member for Ubenide the issue ne is the election of the President, not transport, deo dogin an eko towot engame.

**Mr. Ribauw (Ubenide):** Tubwa Mr. Speaker, anga tsied ngana tsimine wam audo orin ouga am dorer me deo ngea ngea wanga excuse. Ouge anga less than 48 hours. Bita awe pan ian mwim ina, wo ouge 48 hours, quiy. Wo ouge 48 or 24 hours, me ngea oiya anga less than 20, ngea ngea wanga issue, deo dogin bwe ekeow wanga transport me tsimine wam ngawe.

**Mr. Speaker:** Are there any other nominations for the election of the President?

**Mr. Stephen (Ewa/Anetan):** Ogen you leave us no choice Mr. Speaker me ngea wanga nomination oreit kamarareiy ngago it has been staring me right in the face bwe doreret engame me anim

eatu bita ekenibe ero, bita pink. Ateng nominate eiy amea Member for Ubenide, David Adeang, to be President.

**Mr. Ribauw (Ubenide):** Mr. Speaker, ta ererao bed iat duwo ia anim second eiy amune wanga amen Ubenide bwe doreret engame tekei an amune pan. Ima kor ngaben won numpa, so anga happily second eiy.

**Mr. Speaker:** Nomination has been seconded. David Adeang, Member for Ubenide, do you accept the nomination?

**Mr. Adeang (Ubenide):** Animen okaramwen wora min ia ouga Mr. Speaker, tsinia ang ta metu ne me eko edorer mimin ian obwen. Nungi ang ita awaiyida me ang quiaoeiyin gata, that is why anga at this time nan decline eiy.

**Mr. Speaker:** Thank you Member for Ubenide. The Member for Ubenide has declined the nomination. I call for further nominations for the President of the Republic of Nauru.

**Mr. Adeang (Ubenide):** Mr. Speaker, ibibogin nominate eiy amea ngaben Anabar, Ijuw me Anibare, Hon. Ludwig Scotty.

**Dr. K. Keke (Yaren):** Ibibogin second eiy bita nomination, Mr. Speaker.

**Mr. Speaker:** Hon. Ludwig Scotty of Anabar/Ijuw/Anibare, do you accept the nomination?

**Mr. Scotty (Anabar/Ijuw/Anibare):** Mr. Speaker, ibibogin accept eiy bita nomination.

**Mr. Speaker:** Hon. Ludwig Scotty of Anabar, Ijuw and Anibare has accepted the nomination for the President of the Republic. Inga iyu nominations?

**Mr. Ribauw (Ubenide):** Tubwa, Mr. Speaker, ibibogin anga nominate eiy amea Member for Ewa and Anetan, Marcus Stephen, bwe enim take eiy murana etebar as President.

**Mr. Harris (Aiwo):** I second the nomination.

**Mr. Stephen (Ewa/Anetan):** Tekeiy aeo ogiten pan, tsinia tsimine engame tengeiyo bwe anim babiyi murana chair, then I will accept.

**Mr. Speaker:** The Hon. Marcus Stephen, Member for Ewa and Anetan, has accepted the nomination.

Any other nominations for the position of the President of the Republic of Nauru? I see no more nominations me dogin bwe oaro ngana mungana nominations we will go through the process of secret ballot.

#### **Election of President conducted by secret ballot.**

**Mr. Speaker:** I have received the results of the ballot for the election of the President of the Republic of Nauru. Hon. Ludwig Scotty – 14 votes, Hon. Marcus Stephen – 3 votes.

Hon. Members, I therefore declare the Hon. Ludwig Scotty, President of the Republic of Nauru during this Seventeenth Parliament.

**Mr. Scotty (President-Anabar/Ijuw/Anibare):** Mr. Speaker, first of all I want to say I am very honoured by this House, and I believe also the people of Nauru.

Mr. Speaker, eab raquo aeo dorer, I won't talk further because I believe I heard from some source that Members of Parliament speak too much, so Mr. Speaker I believe I will leave it to you as to whether we adjourn the House and come back again or we adjourn the House sine die. I will ask for your discretion, thank you.

**Mr. Speaker:** Hon. Members, what is the wish of the House?

**Mr. Scotty (President-Anabar/Ijuw/Anibare):** Mr. Speaker, animen iyu bed won business ngune ewak, ngea ngea dogin orin oudonuw bwe anim aea wam discretion bwe I believe that there are some administrative work to be done, if the Clerk can give us some advice on that.

Mr. Speaker, ian obwen aeo go further ateng pan ngana eiy imin ouwak eame ia anim obu bitune top position. Ouge anga imin goganedo ngune bitune top position, imin aiya ian meo. I have been in the seat for the last three years, me it really makes me hot iat deden ngea I have to be alert, because I know that all the Members of Parliament in this House are very good people, they represent their constituencies, they represent their people. Ngea ateng pan me aeuwakeiya the whole of Nauru ngana my group, we are very happy bwe the Nauru people oiya gama mandate to which I am very proud. Ateng pan ngana tsinia a lead eiy bitune wora country, for I believe the next term of 3 years, ia mo imin, I believe ngana inan mag roma ia ma, anga me wanga group, ma nan quoquon bwe ma nim put aside won trust dei Naoero.

Tsimine wora problems, tsimine ata yongidu-yongeda but I believe ngana bitune country progress. Tsimine progress we can see me wora ngame nan ied bed wora progress. So, Mr. Speaker, with those few words ateng pan me give all my appreciation to all Members of this House, on behalf of the whole of the Nauruan people, dogin aura tik oiyame bitune honour, bwe they believed in me. I believe, tekeiy aeo pan ngana tsimine wora administrative things ang nim riring, that is why I said it is up to you, Mr. Speaker, it is up to your discretion.

**Mr. Speaker:** Members we will break for lunch and resume at 1.00 o'clock. Thank you Members.

### **Suspension Resumed.**

**Mr. Speaker:** I believe there is a message from the President.

**Mr. Scotty (President-Anabar/Ijuw/Anibare):** Yes, Mr. Speaker.

Mr. Speaker and Honourable colleagues, I am pleased to announce to this august House that over the course of our short break I have appointed my Cabinet Ministers and therefore in exercise of the powers in that behalf vested in the President under Article 23 of the Constitution of Nauru, I, Hon. Ludwig Scotty, M.P., President of the Republic of Nauru do hereby assign to the Ministers of the Cabinet of Nauru the responsibilities for the business of government as described herein:-

Ministers of Cabinet – Hon. Ludwig Scotty, that is myself, as Minister for the Public Service for the Chief Secretary's Department, Cabinet Secretariat and Directorate of Audit; and also as Minister for Police consisting of the Nauru Police Force – emergency services and protective services. Also I am holding the Ministry of Home Affairs consisting of Lands & Survey, Lands Committee, Women's Affairs, Media and Culture.

Next is the Hon. David Adeang, M.P. – Minister assisting the President, Minister for Foreign Affairs & Trade, Minister for Finance & Economic Planning - Department of Finance consisting of Treasury, Bureau of Statistics, Development Planning, Banking and Insurance; and also the Hon. Adeang is holding the Ministry of Utilities consisting of fuel, power and Water.

Next is the Hon. Dr. Kieren Keke, M.P. as Minister for Transport and Telecommunications. The Department of Transport consists of Ports & Shipping, Public Transport and Directorate of Civil Aviation. He is also in charge of Nauru Air Corporation and RONTTEL. He is also holding on to the portfolios of Ministry of Health and Ministry of Sports.

Next is the Hon. Baron Waqa, M.P. – Minister for Education looking after the Department of Education consisting of Education, Youth Affairs and Vocational Training.

Next is the Hon. Frederick Pitcher, M.P. – Minister for Commerce, Industry and Resources. The Department of Commerce, Industry and Resources consist of Tourism, Agriculture, Commerce and Business Development and also looking after Eigigu Holdings Corporation. He is also in charge of foreign investments in offshore registry – Nauru Agency Corporation. He is also in charge of the industry which consists of Republic of Nauru Phosphate (RONPHOS) and Nauru Rehabilitation Corporation.

Last but not least is the Hon. Roland Kun, M.P. as Minister for Justice and Border Control, consisting of Customs & Immigration, Passports and Quarantine. He is also Minister for Nauru Fisheries & Marine Resources Authority consisting of Surveillance, Licensing & Registrations, Coastal fisheries and

Nauru Fisheries Corporation. Hon. Kun is also in charge of the Nauru Phosphate Royalties Trust, in the meantime that this corporation is still operating.

The above assignments of responsibilities for the above mentioned shall take effect on 28<sup>th</sup> August 2007.

Given under my hand this 28<sup>th</sup> day of August, 2007.

Thank you Mr. Speaker and Hon. gentlemen.

**Mr. Speaker:** Thank you Mr. President.

Hon. Members, we will go on to iyiyen wora Standing Committees. First, bita wora Standing Orders Committee.

**Mr. Harris (Aiwo):** Point of order. Mr. Speaker,

**Mr. Speaker:** Is the Member standing on a point of order?

**Mr. Harris (Aiwo):** No, no, procedure, sorry. Ada ngane mungane ang eo gona mwid angogen at the next sitting, bwe ma nim gonan lobby me konani wama ngame?

**Mr. Speaker:** Ang nan proceed with bita ata iyiy wora Standing Committees. Tekeiy amie understand eiy Members ngana ebwak imin ian obweta, ebwak imin ngana ang oreit quoqon bwe enim og, carried forward atsin ean bituno last Sixteenth Parliament. Ebwak bed imin ngana ang oreit quoqon me omag. Members ibun ura ran mungana select committees, me ang tsied ngana ebwak makurin beora. Animen bed Members ogiten bed mwid angogen ngana mungana wangara select committees, ouga aeo tsied, so therefore we will continue with the selection of our standing committees.

Adamonin eiy Standing Orders Committee, and I will call for nominations.

**Mr. Adeang (Ubenide):** Mr. Speaker, ibibogin nominate eiy to the Standing Orders Committee the new Member for Aiwo, the Hon. Dantes Tsitsi.

**Dr. K. Keke (Minister for Health - Yaren):** I second the nomination.

**Mr. Speaker:** Hon. Dantes Tsitsi, do you accept the nomination for the Standing Orders Committee.

**Mr. Tsitsi (Aiwo):** Mr. Speaker, accept eiy bita nomination, thank you.

**Mr. Speaker:** Thank you Member for Aiwo, inga iyu nominations?

**Mr. Adeang (Minister for Finance - Ubenide):** Mr. Speaker, ibibogin nominate eiy the Member for Boe, the Hon. Mathew Batsiua.

**Mr. Waqa (Minister for Education - Boe):-** Mr. Speaker, anga second eiy.

**Mr. Dabwido (Meneng):** Second eiy.

**Mr. Speaker:** Hon. Rykers Solomon, do you accept the nomination?

**Mr. Solomon (Meneng):** Accept.

**Mr. Speaker:** Thank you.

**Mr. Adeang (Minister for Finance - Ubenide):**Mr. Speaker, ateng nominate eiy amea new Member for Buada.

**Mr. Stephen (Ewa/Anetan):** Point of order, Mr. Speaker.

**Mr. Speaker:** A point of order has been raised.

**Mr. Stephen (Ewa/Anetan):** The spots have been filled. I sought your clarification earlier.

**Mr. Speaker:** Yes, I am counting.

**Mr. Stephen (Ewa/Anetan):** ..... me wo oreit allow eiy nominations?

**Mr. Waqa (Minister for Education - Boe):-** Secunder.

**Mr. Speaker:** Hon. Riddel Akua, do you accept the nomination?

**Mr. Akua (Anabar/Ijuw/Anibare):** Mr. Speaker, thank you yes.

**Mr. Harris (Aiwo):** Mr. Speaker, ateng anga nominate eiy amea Ludwig Scotty, eo gona ia eko President iat review, deo mwanin. Eo gona ita keru ino ian an pocket no, ita megada na me eko an dorer ea bitune eb dogit Constitutional review.

**Mr. Scotty (President-Anabar/Ijuw/Anibare):** Mr. Speaker, tsinia ewiname etang, then yes I accept.

**Mr. Speaker:** Hon. Dominic Tabuna, do you accept the nomination?

**Mr. Tabuna (Yaren):** Mr. Speaker, accept eiy me ateng nominate eiy amea Member for Aiwo, Dantes Tsiti.

**Mr. Adeang (Minister for Finance - Ubenide):** Second eiy.

**Mr. Stephen (Ewa/Anetan):** Mr. Speaker, oweiyo bwe enim accept ngea me anga oweiyo bwe anim nominate.

**Mr. Speaker:** Member for Aiwo, do you accept the nomination?

**Mr. Tsitsi (Aiwo):** Accept eiy Mr. Speaker.

**Mr. Speaker:** Thank you Member for Aiwo.

Member for Ewa and Anetan, please megada ken. Resume your seat.

**Mr. Stephen (Ewa/Anetan):** Thank you Mr. Speaker, can you repeat those names please. I am lost.

**Mr. Speaker:** Thank you. Members of the Constitutional Review Committee ngabune, amie Members mwa select eiy ura – Hon. Mathew Batsiua, Hon. Fabian Ribauw, Hon. Kieren Keke, Hon. Riddel Akua, Hon. Ludwig Scotty, Hon. Marcus Stephen, Hon. Freddie Pitcher, Hon. Dominic Tabuna me Hon. Dantes Tsitsi.

Members we will continue with our business.

**Mr. Adeang (Minister for Finance - Ubenide):** Mr. Speaker, tsinia mo burion bitune House, ateng bwe ang nim break eken me ang nan resume ean four o'clock.

**Dr. K. Keke (Minister for Health - Yaren):** Seconding.

**Mr. Speaker:** Members, we will break and resume at four o'clock.

**Mr. Harris (Aiwo):** Point of order.

**Suspension  
Resumed.**

**Mr. Speaker:** Honourable Members we will continue with our business.  
Are there any notices of motions?

**Mr. Kun (Minister for Justice - Buada):** Mr. Speaker, I give notice that at the next sitting I will be presenting the following Bills –

**Mr. Tabuna (Yaren):** Mr. Speaker, I wish to give notice that at the next meeting I will move a motion to re-establish the NPRT Select Committee.

**Mr. Speaker:** Thank you, Member. Inga iyu notices of motions?

Being none, we will continue. We will now come to questions without notice.

There being none, we will continue. Are there any ministerial statements or papers for presentation?

**Mr. Scotty (President-Anabar/Ijuw/Anibare):** Mr. Speaker, yes I have one paper to present.

Mr. Speaker and Honourable colleagues, this government prior to the General Elections on 23<sup>rd</sup> October acknowledged that there were many Nauruans overseas for study, health work or other reasons who would like to cast their vote and exercise their democratic voice in the elections. Therefore, the Electoral (Proxy Voting) Regulations 2004 was approved by Cabinet on October 15, 2004 and was implemented during the 2004 Parliamentary General Elections.

Part III, First Schedule outlines the officers of the Republic of Nauru defined as a witness for the purposes of the Electoral (Proxy Voting) Regulations 2004. On 20<sup>th</sup> July 2007, Cabinet approved the amendment to the Electoral (Proxy Voting) Regulations to reflect the changes in Nauru's overseas missions. The new office in Taipei was included, the new Consul General office in Brisbane and the Vice Consul in Bangkok also are included.

In order to grant the right to vote to Nauruan electors in Kiribati and the Republic of the Marshall Islands, Cabinet Decision of 1<sup>st</sup> August 2007 approved a further amendment to the First Schedule to include appointments of representatives of the Chief Secretary in Kiribati and the Marshall Islands to be witnesses for the purpose of these regulations.

In response to continued demand for proxy voting by Nauruan electors in jurisdictions not covered under the current legislation Cabinet approved on the 23<sup>rd</sup> of August 2007 a final amendment to the Electoral (Proxy Voting) Regulations to include *'any person or persons in a country other than Nauru appointed by the Chief Secretary by notice in the Gazette to be a witness for the purpose of these regulations.'*

In compliance to the above regulations, the Chief Secretary appointed witnesses for the purpose of proxy voting in Samoa, Kosrae, Honiara – Solomon Islands and Tuvalu.

Mr. Speaker, and honourable gentlemen, I am pleased to inform this august House that a total of 477 Nauruan eligible electors overseas were able to cast their votes at the General Parliamentary Election conducted on 25<sup>th</sup> August 2007 made possible through the Electoral (Proxy Voting) Amendment Regulations.

I hereby table in the House the following amendments –

1. Electoral (Proxy Voting) Amendment Regulation 2007 of 20<sup>th</sup> July 2007;
2. Electoral (Proxy Voting) Amendment Regulation 2007 of 1<sup>st</sup> August 2007; and
3. Electoral (Proxy Voting) Amendment Regulation 2007 of 23<sup>rd</sup> August 2007.

Thank you very much Speaker and honourable gentlemen.

**Mr. Speaker:** Thank you Mr. President. Nungi ekeowen iyu wamie presentations me ekeow bed ministerial statements, so we will move on.

Are there any motions?

**Mr. Adeang (Minister for Finance - Ubenide):** Mr. Speaker and Honourable Members, I seek leave to move a motion regarding a matter of breach of privilege and contempt of Parliament.

**Dr. K. Keke (Minister for Health - Yaren):** Seconding.

**Mr. Speaker:** Is leave granted? Leave is granted.

**Mr. Harris (Aiwo):** Mr. Speaker, we could not hear the mumbling away. What are you saying? Seek leave to move what?

**Mr. Speaker:** Leave has been granted. Please continue Minister for Finance.

**Mr. Adeang (Minister for Finance - Ubenide):** Thank you, Mr. Speaker.

I rise, this time, on a matter of breach of privilege and contempt of Parliament allegedly committed by the Member for Aiwo, Hon. Rene Harris.

I wish to inform the House that immediately after the suspension of the House this morning the said Member assaulted one journalist, Mr. Sean Dorney, Pacific correspondent for Australia Network Broadcasting, or ABC, within the parliamentary precincts.

I also wish to inform that the said journalist was discharging his duties when he was assaulted by the Member.

Mr. Speaker and Honourable Members, in a parliamentary democracy the behaviour of Members of Parliament should be such as to enhance the dignity of Parliament and its Members in general. The Parliament has powers to punish its Members for their misconduct either inside or outside the House. The standard of conduct that Members of Parliament are expected to observe is to maintain the highest tradition of parliamentary life. The normal procedure to be followed in this regard is that the matter, on a motion, be referred to the Committee of Privileges to inquire into the alleged misconduct and whether such conduct was derogatory to the dignity of the House and inconsistent with the high standards expected of a Member.

In this case, the Honourable Member has committed a breach of privilege and contempt of the House and I therefore move that this matter be referred to the Committee of Privileges to look into the above incident of misconduct by Hon. Harris and report back to the House with suitable recommendations in this regard. Thank you.

**Dr. K. Keke (Minister for Health - Yaren):** I second the motion.

**Mr. Speaker:** Thank you Minister.

**Mr. Harris (Aiwo):** Mr. Speaker, I wish to ask that the Committee sits very quickly so that we can sort this matter out with the riff-raff from Australia.

**Mr. Speaker:** This matter will be referred to the Privileges Committee and we will expect a report from them a.s.a.p.

Inga iyu motions, Hon. Members? Being none,



**Mr. Scotty (President-Anabar/Ijuw/Anibare):** I move that the House at its rising adjourn until a time and date to be set by your Chair.

**Mr. Adeang (Minister for Finance - Ubenide):** Second eiy.

**Mr. Speaker:** Members, the question is that Parliament at its rising do adjourn until a time and date to be fixed by the Chair.

**Mr. Scotty (President-Anabar/Ijuw/Anibare):** Mr. Speaker, I move that the House do now adjourn.

**Mr. Adeang (Minister for Finance - Ubenide):** Seconding.

Anan join eiy amebuna speakers ian obwo me congratulate eiyuw dogin wam appointment, wam election as Speaker me amea Deputy Speaker. Ateng bed congratulate eiy His Excellency the President, anga tsied from my experience from these last two terms ngana ima ngamen won team amune President, deo ita amebuna rat Cabinet bwe the whole Caucus team.

Me ateng bed otubwa voters ian Yaren, otubwa ura dogin wangara confidence in nim tik oreoano ne ian bitune ewak for the third term me wanga honour iya anim represent eiy dobwain Yaren. Ateng otubwa amebuna wanga supporters, tekeiy wanga campaign managers, tsimineibun ro makur non-stop,

Anga ied an effective bitune opposition from within the Caucus me an nuwaw bitune wama government. Mungana an epo Caucus bwe enim mwid angogen government policies me government priorities me wora direction ngabuna rat Caucus they are more effective ea mungane ewarwar iat ewak bwe iat Caucus ura gona iwid policy, ura gona iwid priorities me mould eiy won government direction from within. Oepoiy ura eat airport, dorera ura, me wish eiy ea ura all the best me aeo tuebon ura. Metan result ion aiqen, me I think that is the beginning of many good results ang nan expect eiy atsin turin bitune wora team ian Samoa.

Ngabune mibune ngaita they are flying Nauru's flag in the Pacific me a tuebon ngana they are going to fly it very high. Ateng hope eiy ngana dei Naoero memak nan follow eiy wangara progress me we will look forward to welcoming them home when they return.

Mr. Speaker, inan dogi ina aeo dorer me anan finish off by saying we are not going to look back, ang nim stay on track. Tubwa, Mr. Speaker.

**Mr. Speaker:** Thank you Minister for Health.

I am looking forward bed bwe anim quoquon me egedu eken engo bwe anim gona mwaiy wanga family, me tsinia eo ouga ogen enim oiyaime another three years bwe anim megada turin bitune Cabinet, both. Eimwi bwe ro nim expect eiy gama bwe ma nim mwaiy amo me makur dogin Naoero. Tubwa Speaker.

**Mr. Speaker:** Thank you Minister for C.I.R.

**Mr. Kun (Minister for Justice - Buada):** Mr. Speaker, ateng bed totow aeo dorer eken ean bitune edae.

Ed ea eb inon mungana amebuna dango ogiten pan, ro fund raise bwo ro nim gona emuk bwo ro nim metu iat politics, ura nim onuwaiw aura makur ina. Ngea ateng pan ngabuna engame ekeow won muk ura enim stand for politics bwe eko imin ro nan gona me re nim eo eke example ngana ma win because we have money. Mr. Speaker, maiy redon me not for the power of money. Truth prevailed, oweiyo ngea iduwen. Ro pat RONWAN, bakan wamaiy dogor bwe ma toerei 40 million, ma torerei 35 million, ma torerei 25 million, ma erow debarin, pwer ama makur. Mr. Speaker, the truth prevailed. Ma pana ura me pana ura, ma pana engame, eko ngana emuk. Meta ngana emuk me ro odet, ro warwar. Mr. Speaker ian bwio mar ake, Mr. Scotty against Mr. Scotty, me ngea amea Mr. Scotty oweiyo ino on the other side eiki bita imin

oreit pan bwe dorer atsin iat NABE. Kaia ngeiy nan dorer atsin iat NABE me anga nan dorer atsin iat basin, eiy dorer adun oe me anga dorer adan ibu, eko imin gona eo win me anga ngea win. Mr. Speaker, why? The truth prevailed! Eko woun ngana China me Taiwan an dorer amuno. Eiy ngago ia enim pan, what? Tsinia eke gama amen Taiwan, eiy amen China ngeiy? What happened?

Dorer eiyin angogen murana ang tuebon, God's Will First. Why not believe in God's Will First? Tsinia eiy full of hate won heart, me engame ibun full of hate, do they believe in God's Will First? Wora good Book tells us to be bad men? Ama good men ngama ian bitune wama government. Ma orin nuwaw dogin bwe ied ngana amebune engame on this side ouga dangoma ngabuna teng ied wama cause, ro teng buok gama dogin bwe ma od ian bita emedena eimwi. Ma eo od ian bita emedena turugago. Tsinia ma teng dar dabuch bwe ma teng publish eiy wama min ma nan come out in the open. Ma eab keru mema oa ma ewewin mema oa ma tamo throw mud to anybody oa omamedo engame, roe burion ngaiura, roe buriot engame. Roe burion amen bwiema, roe burion ngaima, ma sacrifice ine, ma suffer, dogit eken? Dogin ama onuwaiw bitune eb.

We have been going on for the last three years, Mr. Speaker, me I am happy to say tsinia wo nim odet balance, prosper ngune eb. Prosper kor ngune Naoero ngage, prosper amen bwietia. Tsimine suffering eken-o-ken, there is no doubt about that, tsimine an roe engame, tsimine an metur engame me eko engame inan ima through hunger.

Tekeiy aeo pan ian wanga platform ngana ngea hunger ekae ea bitune an tsied bwe ngune bitune wora hunger me an roe buriota dogin bwe ang pudun ean monibaita, ang eo gona mungana eken-o-ken, ang auwe bita power of money. Ngabuna hunger ino somewhere we know ro nan hunger eaden aura redo duwora me iman, ita bones ngea bita engame, ngana pudu na ita bones duwon.

Mr. Speaker, ngana ngane ngane engame enim aea. Ouge anga a eo magit proud eow ean, bita enim gagoda iyaeo bwe proud eow ean bitune wanga government me proud eow eat engame ngabuna support eiy bitune wanga government me anan proud eow ean bed amebune Members tsimeduw tsinia ro nim bwaida aura kamara bwo ro nim ied mungana imin mo ngana ma oreit nim omamo. Mr. Speaker, tekeiy aeo pan ngabuna engame oreit ied ura iat platform, ngabuna engame oreit ied ura omamedo bitune wama dogor, me ura komamedo me ura oworongeora mimin, yes I pity them. Auwe ura dogin bwe negative aura kamarar me they think tsinia ro ouga inan ura Members of Parliament. Ura eiki yen ngea ura fool eiy. Ura fool eiy the good Nauruan people? Inga ngage? The good Nauruan people have shown that they cannot be fooled. Ura return eiy gama dogin bwe the truth prevailed. Ma oweiyio iat iduwen, ma eo quiy tsinia ma dorer. Ma eo lie, mag roman onuwaiw imin ian ama makur epoa wama Temoniba iat partnernship. Eko wouna gama ngana emuk bwe ngana emuk ma oiya amen bwiema. Engame ibun eama ne ro tsied, ama bed, ma owenot emuk me engame ibun ian wanga government totow memak ngea bita emuk. Inga? Ura oreit win bed ian wangara tekawa.

Mr. Speaker, I am very happy to see my people back. Anga meg iat office bwe anim ere egora, one by one. Ngabuna witen ere in egora, nuwawen me totu in ian murana list on my left side with a few tears a shred eiyin, why? Dogin bwe ibuok gama, oiya gama ipuok. Eben bwietia Naoero, ngamen bwietia Naoero, me wora Temoniba oiya gama ipuok. Mwa eo gona ouge mwa nim ta akoda ina tsirungin bwe oiya gama ipuok bwe ituebonon gama bitune eb bwe ma nim onuwaiw. Tsimine engame inat tuebon ura bwo ro nim onuwaiw eb, me etsiok aura dae, oreit groom eiy ura, me ngabuna ouge bwe ro nan eowit eb dogin bwe ura win iat Constitutional Convention inan meta bitune an ake engab me eoning me ro nan meg ino magin yong. Truth prevails!

Ngea ang nim odet me ateng bed pan, Mr. Speaker, bituno national progress. Inga ang nim kudoiy gata, progress bwietia oa ekeow? From four years back, inga wora toa, inga an memori imin, otenamwanin tsimorit engame, bwaini oangara, inga wangara cargo orre, inga deimanu, inga wora debarin, inga wora phosphate production line, inga wora mooring system? Mr. Speaker, zilch! Eko memak ngane me tsinia ang nim iwidoduwa ngage, magen ngune eb. We are looking at 30 to 40 years, engame ouge panen this is a menga government, yes in times oc crisis we may be menga me ita ngana a menga with co-operation and friendliness, ngea totow ben Naoero iat ekewin.

Anga gotow Japan, anga me amea Foreign Minister bwe ma nim repair eiy bita damage done, ma goto ian Australia bwe ma nim repair eiy bita damage done, ma gotow ian Taiwan bwe ma nim repair eiy mungana damage done, ma metuwa Forum bwe ma nim repair eiy mungana damage done. We did well me ma orreaten Donors Round Table ne, yes it is a menga country, yes me wo on otsini wodom? Engame ibun ouge miracle, wo ita ouge bem me pudut emuk atsin iyarat ini. Mr. Speaker, ngoto ngaga inan pudu emuk atsin iyarat ini. Ita won Uncle Scrooge. Ma earn eiy ngune emuk, ma earn eiy kor.

Anim panaw Mr. Speaker me honourable gentlemen, we have had 30 to 40 years more of happiness, we are right there we are at the end. Nuwawen wora imin, ang nan pumwe it idura, ipumwe it royalties, pumwe it beneficiaries, iyuwen RONWAN, imin memak ngane inan dereder before the end of this year. What about next year? We will build up, tekeiy kor ama pan.

Engame owodu gama ngaga anga pan ngana ma oyon ngana mungana seeds bwe enim grow bwe enim eiy imin ero eon dobar me meta kauwen boiyarara, we will benefit then Mr. Speaker. Maybe anga, gona iya my time is counting me inan ita nuwaw bwietia me ngea imin anan ibibogi eiy ma set legacy ngage. Amie me ama ang set eiy legacy, dogit eken? Dogin mibuna ngaita kadudu, ura oning ngage. Tsinia ang ied ura ura engame ibun ang kam dogon ura, ro kadudu, ataiyemwa ibwun amea me ataiyema ibwun amea me oarumen ibwun amea me ouga ma ouga. Ang kania ura me ro kadudu, tsinia wo redo eow bwiem ro amaruw, tagegeiy nanam me eken ngea imin wo set eiya ura Mr. Speaker. Tsimine wama plan, ma omamo wama plan iat NSDS, towada bed wama plans ma makur ea engame ange, ma makur ea ura bwe dogit eken? Dogin bwe ang nim gor on the right track.

Ouge amea amen Yaren don't look back, stay on track. Kaia inan ouge bitune wanga government we don't settle for less, Nauru must progress. Mr. Speaker, tubwa me otubwa gamie memak me otubwa ngamen bwietia Naoero me of all otubwa ngamen Anabar, Ijuw me Anibare dogin aura oiyame 25 years of serving them. I will keep on serving them, I am very proud to be the President of Nauru. Tubwa kor.

**Mr. Speaker:** Thank you Mr. President.

Before I put the question, animen fair tsinia enim anga bed me tsimine aeo daein dorer. Before the last sitting ngago ang nim dissolve, tsimine wanga statement a gadauw me kaia ouga bwe anim eo retsineiy bwe anim obereiy bitune edae ngage. Ateng retsineiy bwe ngaga a iedin eo gona kor an towe ngarana imin dogin, especially bita relationship between the Chair me Members on the floor. Ateng bed retsineiy ian dorerin burbur me og me anan dorer eiy ian gakairin bwietia.

I have done my best, since ngage ma elect eiyo I will continue to do my best in endeavouring to serve all interests of all Members on the floor of this House based on practices and conventions of the House even though some may not agree at times on the things and the way I conduct our proceedings. I firmly believe that nothing unusual had been done as it is common practice everywhere in the world for Members to disagree with the Chair. But I can certainly tell you that many times life is certainly lonely at the top here, and it is no easy feat to control the House when it is at its rowdiest.

Ngea oreit pan ina, tekeiy magin ro. Ebwak edae, iduwen, Members eab agree ea mungana wanga ruling or aeo conduct eiy ata epo, me ita ngana ngune bita an ebwak edae ang eo arowong kaia common memak ian mungana Parliament mago. Ngea anim konga gamie, mwa nim understand eiy ngana mwa ebwak ino yong, me ngana yong mwa gona babiyi bemie tsinia mwa warwar mwa nim eo meyion ngana ngane ituga eko engame nim babiyi beo ean mungana edae ngana oreita babaka wora imin.

Ngaga ouga, anan eduwa bita wanga hat as Speaker me as Member for Ubenide, adamonit imin anim otubwa amen bwio me amen bwio kor turename ita ura tsied ura, amen bwio me dango ian wanga tekawa me mibuna dango kor. Ngea ouwakin bed ateng obu bitune edae me give my personal thanks ametsimine wanga colleague ngaga bed ekeow eiyo dogin ama join hands ino ean wama platform. Yes, Members nan pan ngana nungi nineteen against the three.

Ngea bed ateng pan me a eab tik oraquo bed ngana gain onungo dogin bwe ean wama platform ouwak kor tamwiden amerumena dango me aroen burio dogin ngaga eko engame tamwido especially dogin aeo makur iat Parliament. Oweiyon bed me pana in ngamen Ubenide bwe mungana imin towe Parliament mwa nim oudono a mangada, so I guess ngana eo dogedog imin. Me ita ngana ateng otubwa gamie dogin mungana wamie comments me remarks mwa address eiy eame, wamie trust eame me animen kaia ouga bed ngabuna amen bwio ian Ubenide.

Other than that, members, I will put the question. The question is, that Parliament do now adjourn.
